Speaker Profiles 9th Annual Contract Faculty Colloquium

Angela Anderson (Sessional Lecturer, Creative Studies)

Angela Andersen teaches Art History courses for the faculty of Creative Studies at UBCO that explore both contemporary and historical art and architecture. Her research engages the inter- and intra-religious interactions that take place via the built environment in Muslim contexts, with a focus on the architecture of minority and marginalized groups. She also works with not-for-profit organizations, museums, and educational institutions to focus on the role of architecture in human rights and community wellbeing. Her publications examine the development and use of ceremonial settings, the social and legal ramifications of the oppression of religious sites, and the collection and analysis of oral history and verse as tools for examining the meaning of religious architecture. Andersen is an Associate Editor with the International Journal of Islamic Architecture, and the Program Coordinator of the Epidemic Urbanism Initiative. She also runs an after-school programme for children focused on ideas related to creating and learning about architecture.

Suzanne James (Lecturer, English)

Suzanne James has been teaching in the English department at UBC since 2006, first as a sessional and more recently as a contract lecturer. She oversees the department's First-year Program and has been Chair of the African Studies Minor program for the last five years. Although her PhD is in 19th century Canadian literature, most of her teaching involves contemporary fiction, African literature and Children's literature. This presentation is a condensed version of a paper delivered at a conference in Boston in March of this year.

Isabel Machado (Lecturer, GRSSJ)

Dr. Isabel Machado is a cultural historian whose work often crosses national and disciplinary boundaries. She specializes in the fields of Gender and Sexuality Studies and Celebration Studies. Her first book, Carnival in Alabama: Marked Bodies and Invented Traditions in Mobile (2023), uses Mardi Gras as a vehicle to understand

social and cultural changes in Mobile in the second half of the 20th century. For the ongoing oral history project, Queens of the South, she is interviewing performers who defy gender normativity in different parts of the globe. She is a Lecturer in the Institute for Gender, Race, Sexuality and Social Justice and serves as co-editor-in-chief for the "Journal of Festival Studies". Her work has been published in "Study the South, Oral History, O Olho da História, and Journal of Festive Studies".

Meredith Beales (Lecturer, Journalism, Writing and Media)

Meredith Beales has been teaching at UBC in the WRDS program since 2016, shortly after she received her PhD in English literature from Washington University in St. Louis. She has been a lecturer since 2020. Her teaching focus has been on academic writing and the first-year experience, but her scholarly background is in English Renaissance literature. She has previously published chapters and performance reviews on Shakespeare, history, and ballet. The paper you will hear today was part of the "Criminal Shakespeares" seminar at the Shakespeare Association of America Conference in April 2024.

Arianna Dagnino (Sessional Lecturer, FHIS)

Arianna Dagnino holds a PhD in Comparative Literature from the University of South Australia and currently teaches in the Italian Studies program at the University of British Columbia. She conducts research on transcultural writing and literary self-translation, for which she was awarded a SSHRC postdoctoral fellowship at the University of Ottawa. Her scholarly publications include the monography "Transcultural Writers and Novels in the Age of Global Mobility" (Purdue UP, 2015). Her academic background also informs her creative work. She is the author of the post-apartheid novel The Afrikaner (Guernica, 2019) and of two poetry collections, "Seaborn Eyes" (Ekstasis, 2021) and "Love Scores" (in press) – www. ariannadagnino.com
